CLASSES

Classes will be held in the summer, winter and fall semester.
Nrityasudha may cancel and reschedule classes at any time for any reason.

FEEES

The fee for each student's participation in each semester of classes shall be \$_____ per semester, postdated checks equal monthly payments of \$_____ prior to the first class held in each semester.

TRANSFER

Internal Tran: *"Give us ahead of time notice so we will suggest best person who suits to our Bani/Style."* Along with Nrityasudha dance lessons/ training if a student wants to build an extra skills in Natya,Nritya & Nrrita ,then transfer is welcome! If required, then teacher will suggest taking extra help from other teacher. (*More info@ Nrityasudha website*)

External Tran: student or their parents can choose anytime transfer to School, Institution or with any teacher. Refund check will be given for only those classes which you have not attended.

REFUNDS

All fees paid are non-refundable except:

- (a) in the event of a family emergency or the student moves away from the Albuquerque area, Nrityasudha will refund the prorated balance of fees;
- (b) in the event a student is unable to complete a semester because of illness or injury, Nrityasudha will refund the prorated balance of fees;
- (c) in the event Nrityasudha is unable to reschedule a cancelled class, the fee for that class will be credited toward the next month's fees or, if a student has paid for an entire semester, Nrityasudha will refund the prorated balance.

PARENT/GUARDIAN PARTICIPATION

No parent or guardian of any student, and no other observers shall be allowed to interfere in any way with any lesson. This includes coaching from the sidelines, coming onto the dance floor during a lesson, or yelling instructions to a student or the dance teacher during a lesson. The teaching process can involve the dance teacher sometimes giving students advice, coaching, or critique related to the student's effort and concentration. No parent, guardian, or other person shall interfere with the giving of such advice, coaching, or critique. The only recourse in the event a parent or guardian disagrees with Nrityasudha's teaching method is to withdraw the student from future classes.

DISENROLLMENT

Nrityasudha may in its sole discretion disenroll any student from participating any one or more classes for the following reasons:

- (a) nonpayment of fees when due;
- (b) physical and/or verbal abuse of any Nrityasudha teacher or staff member by any student or the student's parent or guardian through **Email, Phone, Text or any social media.**
- (c) a parent or guardian's violation of the participation policy above;
- (d) disruption of a class or the teaching process by any student, parent, or guardian; or
- (e) the student, parent, or guardian's failure/refusal to comply with any safety signs, rules, or verbal instructions of Nrityasudha teachers and staff.

LIABILITY WAIVER

In consideration of being allowed to participate in any activity at Nrityasudha, the undersigned, on his/her behalf, and on behalf of the student(s) identified above, acknowledges, appreciates and agrees to the following conditions:
